The Centre for Marine Living Resources and Ecology (CMLRE), an attached office of the Ministry of Earth Sciences, Government of India is inviting application from eligible retired Scientists/Professors who worked in Government/University/Autonomous organizations to be engaged as consultant on contract basis following below given criteria and terms & conditions.

**Eligibility Criteria** - A scholarly person with minimum of 20 years of research experience in the field of Marine science and possessing doctorate degree in any of the subjects like Marine Biology/Oceanography/Fisheries/Microbiology/Biotechnology or equivalent to Natural Science.

**Nature of Duty and Responsibility** - Assist in the implementation of the ongoing research program, identification of future research needs, formulation of new activities, preparation of project documents and proposals and any other duty assigned from time to time by Director, CMLRE.

In addition to the duties detailed above, Specific responsibilities of the consultant include preparation of taxonomic catalogue, creation of microbial genomic reference facility, design of world class museum and taxonomic centre, and guiding project students with regard to their activities aiming to achieve project deliverable and pursue higher degree.

**Number of posts : 3 Nos.** (To be filled only when suitable candidates are available).

**Age Limit** - Candidates should not be more than 65 years of age as on last date of the application (14<sup>th</sup> September 2017).

**Contract Period** - Initial contract would be for a period of one year and further extension would be considered upto the end of project period (i.e. the year 2020) after performance review.

**Selection** – Selection would be based on an interview by a duly constituted committee after taking in to account candidate's health, capabilities, willingness to work, contributions to science in the relevant field and overall vision for the institute.

**Remuneration/Terms of Payment** - The payment would be fixed as per the prevailing guidelines and norms of DoPT. Indicatively, the admissible remuneration would be based on the formula of the DoPT i.e the Total Pay = Last pay drawn + DA)-(Pension + DA thereon). Nevertheless, the actual remuneration would be fixed by the committee during the time of interview.
